



BYLAW

Bylaw Number: 1286/17

A BYLAW OF THE MUNICIPALITY OF THE TOWN OF NANTON IN THE PROVINCE OF ALBERTA TO SET FEES AND RATES RESPECTING SERVICES AND GOODS PROVIDED BY THE TOWN OF NANTON.

1. PURPOSE:

- 1.1. WHEREAS, the Municipal Government Act, being the Revised Statutes of Alberta 2000, Chapter M-26, and amendments thereto, authorizes a Municipal Council to pass bylaws to establish and charge fees and rates, and
- 1.2. WHEREAS, Council deems it proper and expedient to set fees and rates, as may be amended from time to time, respecting:
 - 1.2.1 Municipal Utility services and supply provided by the Town of Nanton, including, but not limited to, water, wastewater and sewers, storm sewers and plumbing, and
 - 1.2.2 Business License fees.
- 1.3. NOW THEREFORE, the Council of the Municipality of the Town of Nanton in the Province of Alberta duly assembled enacts as follows:

2. SHORT TITLE

- 2.1. This Bylaw will be cited as the Fees and Rates Bylaw # 1286/17.

3. GENERAL PROVISIONS

3.1 Severability

It is the intention of Council that each separate provision of the Bylaw shall be deemed independent of all other provisions herein and it is the further intention of Council that if any provision of this Bylaw is declared invalid, all other provisions hereof shall remain valid and enforceable.

3.2 Fees, Rates and Charges


- 3.1.1 The fees, rates and charges contained in the attached Schedules and forming part of this Bylaw shall be the fees, rates and charges in effect for the provision of goods and services stated.

3.3 Associated Bylaws

- 3.3.1 The Water Rates and Wastewater and Storm Water Rates, attached as per Schedules "A" and "B" respectively, as stated within this Bylaw, shall be the rates in regards to the current Town of Nanton Municipal Utility Bylaw, and any amendments thereof.
- 3.3.2 The Town of Nanton Business License Fees, attached as per Schedule "C" and stated within this Bylaw, shall be the rates in regards to the current Town of Nanton Business License Bylaw, and any amendments thereof.

4. EFFECTIVE DATE AND READINGS

- 4.1 This bylaw comes into full force and effect as of March 1, 2017, thereby repealing Town of Nanton Bylaw #1282/16.
- 4.2 Read a **first** time this 21st day of February, 2017.
- 4.3 Read a **second** time this 21st day of February, 2017.
- 4.4 Read a **third** time this 21st day of February, 2017.
