



# BYLAW

Bylaw No. 1350/21

---

**A BYLAW OF THE MUNICIPALITY OF THE TOWN OF NANTON IN THE PROVINCE OF ALBERTA AUTHORIZING AN AMENDMENT TO BYLAW #1094/00 BEING A BYLAW TO PROVIDE FOR THE CONTROL, CARE AND REGULATING THE USE OF THE NANTON CEMETERY.**

WHEREAS it is deemed necessary to provide and update regulations and controls for the operation of the cemetery that is operated and maintained by the Town of Nanton; and

WHEREAS: Pursuant to the provisions of the Municipal Government Act, R.S.A. 2000, Chapter M-26 as amended, and the regulations set forth in the Cemeteries Act, R.5.A. 2000, Chapter C-3, Council of the Town of Nanton deems it appropriate to pass a Bylaw of amendment.

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE TOWN OF NANTON IN THE PROVINCE OF ALBERTA DULY ASSEMBLED ENACTS AS FOLLOWS:

**1. AMENDMENT:**

Bylaw #1094/00 is hereby amended as follows:

1.1 Schedule 'A' is repealed and replaced with Schedule 'A', attached to and forming part of this Bylaw #1350/21.

1.2 Strike out section 7.14 and insert the following in its place:

7.14 *Burial or funeral services shall be permitted in the cemetery on a Saturday, Sunday or Statutory Holiday only under the following circumstances:*

7.14.1 *No less than five (5) business days' written notice has been given to the Manager of Operations or designate to schedule personnel and equipment; or*

7.14.2 *Town Administration staff have first confirmed in writing with the Manager of Operations or designate that personnel are available to provide burial or funeral services on the date and time requested: and*

7.14.3 *The Weekend or Statutory Holiday surcharge is paid in full.*

**2. EFFECTIVE DATE AND READINGS:**

2.1 This Bylaw hereby repeals Schedule "A" of Bylaw #1196/08, as per 2.1.3 of Bylaw #1196/08, and this Bylaw #1350/21 will be effective immediately upon signing.

2.2 Read a first time this 7<sup>th</sup> day of June, 2021.

2.3 Read a second time this 7<sup>th</sup> day of June, 2021.

2.4 Read a third time and finally passed this 7<sup>th</sup> day of June, 2021.
